

PRIVACY POLICY

By registering on www.jey.today as a User, visiting this resource for the purpose of obtaining information, you agree with the submitted Privacy Policy. Administration www.jey.today, in its queue, understands and recognizes the importance of data confidentiality of Users.

Jey Today, the Limited Liability Company is the owner of the Site Jey Today, with which you enter into an agreement (hereinafter referred to as " **Jey Today**", "**we**", "**us**", "**our**"). www.jey.today (in hereinafter referred to as the "**Site**") is an e-commerce platform and mainly is used by legal entities to promote an electronic commerce and, as a rule, does not imply the collection of personal data of individuals. Jey Today realizes the importance of maintaining confidentiality of Personal Data. This Policy Confidentiality applies to all items and services, provided on the electronic trading platform and indicates how we can collect, use, disclose information related to the users of the Site. You can use our services and products through mobile devices, applications for mobile devices or mobile versions of website. Such use of our services and items is also governed by this Privacy Policy.

This document defines the policy of processing of personal data, and it also contains information on measures being implemented to protect personal data and it is designed to fulfill the requirements of The Federal Law of July 27, 2006 No. 152 "On personal data" and other normative and legal acts that determine the order of work with personal data and requirements to ensure their security. The Confidentiality Policy uses concepts in the sense that which they are given in Article 3 of July 27, 2006 No. 152 "On personal data ". By the operator of personal data (hereinafter **Operator**) is implied the Jey Today LLC.

By filling out the registration form on the Site, one accepts this Privacy Policy in order to promote items and services on the market through direct contacts with potential consumers on the e-commerce platform and therefore, you express a will and give a voluntary consent to process your personal data in the manner prescribed by law.

1. DATA COLLECTION

You voluntarily and knowingly provide Personal Data about yourself when you create an account (register) on the site and when you subscribe to receive electronic information. Scope of personal information that you disclose is determined solely by the User.

1.1. The inviolability of your privacy is important to us, and we have taken steps to ensure the collection of her or his data only in the amount which is necessary for us to provide services and to protect user's account.

1.2. The following data, including but not limited to: username, address, telephone number, fax number, e-mail address, TIN, the address of the organization's location, last name, first name, middle name, gender, date and/or year of birth and user preferences (collectively, "**Registration Information**") - can be collected during registration on the Site.

1.3. In accordance with any transaction and services for payment or services, provided by the user protection programs, provided by us on the Site, the following data, including but not limited to: numbers of bank accounts, payment information and information about the place of delivery, credit/debit card numbers and expiration dates, data of checks and payment orders (all together - «**Banking Information**») - can be collected along with other information for promotion of sales and purchases, as well as to reconcile the purchase price goods or services sold and ordered.

1.4. We record and store details of consumer actions on the site. Information relating to such actions, including, but not limited to: types and characteristics of items, prices, information about delivery and any records of trade disputes (collectively, "**Information on Actions**") - can be collected when conducting sales transactions online.

1.5. Periodically, we collect data about our users and potential users during exhibitions, industry and other activities. Data that can be collected by us in such places, include but are not limited to: user name, address, phone number, fax number and e-mail address (all together - "**Information from Activities**").

1.6. We record and store data about user actions on our platform for buying and searching, including, but not limited to: IP addresses, search models and models of the buyer's behavior. In addition, we collect statistical information about sites and their visitors, including, but not

limited to: IP addresses, Internet browser program, operating system, software and hardware, pages viewed, number of visits and visitors (collectively, the "**Search Engine**"). Technical information can be collected automatically while visiting the site by software. This category includes the IP address of the computer or proxy server, the name, domain, information about the date and time of visiting the site pages, about the site, with which one makes the transition to the Site. This information is available from standard server logs.

1.7. Registration Information, Banking Information, Information on Activities, Information from Activities and Search Engine are mainly related to legal entities and together referred to as commercial data (hereinafter referred to as "**Commercial Data**").

1.8. Users provide certain Commercial and Personal Data required for registration and provision such user of the e-commerce platform.

2. PURPOSES OF USE OF PERSONAL DATA

By providing Personal Data to us, one thereby confirms that one agrees to collect, organize, accumulate, storage, use, transfer, block, remove and destruct of Personal Data for the following purposes:

2.1. Confirmation of one's identity (User identification);

2.2. Confirmation of one's right to register as a user online;

2.3. Processing one's registration as a user, providing one's ID to enter the Site, maintain and manage registration;

2.4. Providing you with customer service, Internet service for work with contracts, identification of parties within the framework of services, agreements and contracts with the Operator, as well as answers to your questions, reviews, requirements and claims;

2.5. Ensuring interaction between buyers and sellers on Site, processing of your transactions on the Site, promotion of items and services provided by you on the market;

2.6. Implementing the analysis of attendance of a resource in order to optimize its work and develop proposals for its further development and improve the quality of the services we provide (assess and improve products and services, develop new products or functions, and carry out inspections and take measures to eliminate errors, problems);

2.7. If you receive your consent in a form that does not contradict the current legislation, we (including our affiliated persons and the service providers appointed by the latter) shall have the right to use your Registration Data to offer you information letters, research, information about new products, information materials and other promotional materials related to the items and services offered on the Site, including, but not limited to membership in the premium account (referred to as the "**Membership**"), additionally paid services, related to Membership, and other items and services, periodically offered by us and/or our affiliates and appointed by the last Service;

2.8. If you voluntarily send any information to the Site for publication on the Site through publishing tools, including, but not limited to: Information about the Company, Catalog of Products and Services, User Guides, Profile or any forum, it is considered that you agreed to publish such information on the Site (further on "**Voluntary Information**");

2.9. Disclosure of information that is necessary for any of the above purposes or required in accordance with the current legislation, regulations, rules and regulations.

3. PROCESSING OF PERSONAL DATA

3.1. The processing of personal data by the Operator is carried out with the only consent of a subject to the processing of his Personal Data.

3.2. Processing of personal data is necessary for the exercise of rights and legal interests of the Operator and/or third parties or to achieve socially significant goals, provided that they are not violated at the same time.

3.3. The processing of personal data is carried out by the Operator in statistical or other research purposes under condition obligatory depersonalization of Personal Data.

3.4. When collecting personal data, the Operator provides a record, systematization, accumulation, storage, clarification (updating, modification), extraction of Personal Data using databases located on the territory of the Russian Federation.

3.5. The operator can carry out a cross-border transfer of Personal Data in cases of concluding contracts with users and counterparties abroad in the amount necessary to conclude and execute such contracts. In the transboundary transfer of Personal Data to countries that are not parties of the Council of Europe Convention on the protection of individuals Personal Data in the automated processing or not providing adequate protection of Personal Data, subjects of Personal Data agree to such a transmission in writing.

3.6. By registering on the Site you agree that we may disclose or transfer your Personal Data to the Site users - suppliers and buyers of items and services, to assist in the provision of our services (including, but not limited to: data entry, database management, promotion of items and services, information about new products and services, delivery, deferral of payments, identification and confirmation of members, organization of transportation and others).

3.7. In the cases provided by the current legislation, we may disclose or transfer your Personal Data to the public law enforcement and other control and supervisory bodies and departments and courts.

3.8. Personal Data provided by you to us will be retained and will be available to our employees, Service Providers and third parties mentioned in paragraphs 3.7 and 3.8 in connection with goals, as set out in paragraphs 2.1.

3.9. All Voluntary Information can be accessed publicly on the Site and therefore is open to any Internet user. Any Voluntary Information disclosed by you becomes public information. You must be careful when making a decision to include personal or business information in Voluntary Information that you send to us.

3.10. We are entitled to provide your Banking Information to banks or suppliers to ensure conditions for the execution of your transactions on the Site. In addition, we can use your Bank Information for assistance to you in conducting transactions on the platform of electronic commerce. We have modern technologies and internal procedures for protection of your Banking Information from outside interference, however, we do not guarantee that such technologies and procedures will exclude all risks associated with theft, loss or unlawful use.

3.11. We are entitled to provide statistical information to third parties, but performing this we do not transfer Personally Identifiable Data without your consent.

3.12. We have established relationships with third parties and the Internet sites to offer you the advantages of items and services that we do not provide. We grant you access to such persons and their Internet sites or through posting on the Site hyperlinks to these sites, or through the provision of access to joint sites on which we together with third parties use a single resource index, domain name or pages within a domain on the Internet. In some instances you will be required to provide Personal Information for registration or ordering of items and services supplied by such third parties and partners. This Privacy Policy does not apply to such third-party sites or joint sites. The privacy policy of third parties may differ from ours, and we do not have control over the information that you transmit to these third parties. You should familiarize yourself with the relevant security policy sites of third parties and joint sites by responding to any Proposals, items or services advertised by third parties.

3.13. The processing of the User's Personal Data in order to promote items and services on the market by making direct contacts with the potential consumer through means of communication is allowed only with the prior consent of the subject of Personal Data. Acceptance of the terms of this Privacy Policy means that the User has expressed his will and consent to such processing of Personal Data.

4. PROTECTION, ACCESS RIGHT, CORRECTION OF PERSONNEL OF DATA

4.1. The Operator independently determines the composition and list of measures necessary and sufficient to ensure the fulfillment of duties provided by legislation in the field of Personal Data. The Operator and persons responsible for the processing of personal data who have access to Personal Data must not disclose to the third parties and do not distribute personal data without the consent of the subject's Personal Data unless otherwise provided by federal law.

4.2. According to the current Russian legislation, you have the right to access the personal data we hold, and require the operator of specification, block or destruction of his personal data in case if Personal Data are incomplete, obsolete, inaccurate, illegally obtained or not

necessary for the stated purpose of processing, and also to take measures to protect their rights provided by law.

5. USING COOKIE FILES

5.1. We use cookies (hereinafter "**Cookies**") for storage certain information about you and tracking of your visits to the Site. Using cookies is a common practice of internet sites to improve the identification of its users.

5.2. Cookies are a small amount of data that is sent to your Internet browser and stored on your computer's hard drive. If you do not block or erase Cookies, each time you use the same computer to log on to the Site, our Web servers will be notified of your entry to the Site, and we in return will receive information about your visit and model of your use.

5.3. As a rule, we use Cookies for your identification and for providing us with the opportunity:

5.3.1. to provide access to your Registration Information or Banking Information to avoid the need for re-entry of information by you;

5.3.2. to collect static usage information;

5.3.3. to study a model of visits and orientation assistance of promotional materials based on users' interests;

5.3.4. to assist our partners in tracking visits to the Site and processing of orders;

5.3.5. to track progress and participation in promotions.

5.4. You have the right to determine how and in what cases will be accepted Cookies, by configuring the Internet browser installed on the computer that you use to log into the Site. If you wish, you can always change these settings. By setting preferences in Internet browser, you can accept all Cookies or you can select a notification that your Internet browser is directed to Cookies, or you can reject all Cookies. If you reject all Cookies by selecting the function to block Cookies in your Internet browser, you may need to re-enter information on the Site more often and certain services on the Site will not be accessible to you.

6. MINORITY

6.1. Sites and their content are not intended for minors (persons, under the age of 18), and we do not intend to sell any of our items or services to minors. Despite this, we have no means determining the age of people visiting our Site.

6.2. If a minor has provided us with personal information without consent of the parents or guardians, the parent or guardian should contact us at the address specified in section 4 for the deletion of such information.

7. SAFETY MEASURES

7.1. We use commercially reasonable security measures for preventing unauthorized access to the Site, maintaining correctness of stored data and ensuring correctness of information use we have stored.

7.2. Registered users of the Site can view and edit Registration and Bank Information through the login protected by a password. We strongly recommend that you do not disclose your password to anyone. Make sure it is not too simple and short. If you suspect that access has become known to others, immediately change the password. Our employees will never ask you to provide your password through an unsolicited call or email. If you share a computer with another person, you should not store your login information (for example, name user and password) on that computer. Do not forget to log off and close the window of your Internet browser when you end your session. Do not select the "remember me, in case you are working on a public computer.

7.3. No data transfer via the Internet or wireless networks can be completely safe. Thus, in spite of the fact that we try to protect the information stored for you, we do not guarantee security of data transmission to us, and you assume the risk of such transfer. Protection of

user information is carried out on the site in accordance with this Privacy Policy. In addition, generally accepted measures are used to protect information from distortion, unauthorized distribution and loss.

8. CHANGES TO THE PRESENT PRIVACY POLICY

8.1. The Site Administration reserves the right, without prior notice, alerts and makes any changes at any time to this Privacy Policy, which will be brought to the notice by additions or new versions to the Security Policy on the Site. The new Security Policy takes effect immediately after publishing on the Site.

8.2. You confirm that the latest version of the Security Policy will regulate matters related to any of saved information about you (as described in this Privacy Policy and regardless of whether they were collected before or after the entry into force of the new Security Policy). If you are from the Russian Federation or if you are outside of Russian Federation, the conditions are regulated in accordance with legislation of the Russian Federation.

8.3. If you are from Russian Federation or if you are from outside of Russian Federation the Terms shall be governed by the laws of Russian Federation without regard to its conflict of law provisions and the parties to the Terms agree to submit to the exclusive jurisdiction of the courts of Russian Federation.

8.4. PARTIES UNDER THIS PRIVACY POLICY THOSE RECOGNIZE THAT THE COURTS OF THE RUSSIAN FEDERATION HAVE THE EXCLUSIVE JURISDICTION WITH REGARD TO SETTLEMENT OF DISPUTES.

8.5. In case of any discrepancy between the Russian version and the version in another language, the version in Russian prevails. Any versions of these terms and conditions, which are not in Russian, are provided only for reference purposes.
